ARE YOU REAL ID READY?

ARE YOU PLANNING A FLIGHT THIS YEAR? STARTING MAY 7, 2025, IF YOU'RE PLANNING TO FLY DOMESTICALLY IN THE US, THE TRANSPORTATION SAFETY AUTHORITY (TSA) WILL REQUIRE FLIERS TO HAVE A REAL ID COMPLIANT DRIVER'S LICENSE/ID, US PASSPORT OR OTHER DOCUMENT TO FLY. THE REQUIREMENT FOR REAL IDS WAS PLANNED FOR 2021, BUT DELAYED DUE TO THE COVID-19 PANDEMIC. NOW, STARTING IN MAY IT IS SET TO GO INTO EFFECT.

MADE AS EDUCATORS, MENTORS AND LEADERS.

- 1920 Women are granted the right to vote thanks to the 19th Amendment.
- 1968 <u>SHIRLEY CHISHOLM</u> A STRONG SUPPORTER OF BLACK CIVIL RIGHTS AND WOMEN'S RIGHTS. IN 1968, THE UNBOUGHT AND UNBOSSED CHISHOLM WAS THE FIRST BLACK WOMAN TO BE ELECTED TO THE UNITED STATES CONGRESS.
- 1981 <u>SANDRA DAY O'CONNOR</u> IS THE FIRST WOMAN APPOINTED TO THE UNITED STATES SUPREME COURT.
- 1983 SALLY RIDE BECOMES THE FIRST WOMAN IN SPACE.
- 1984 <u>Geraldine Anne Ferraro</u> An American Politician, diplomat and attorney. She served in the United States House of Representatives and nominee for vice president in the 1984 presidential election, this made her the first female vice-presidential nominee representing a major American Political Party.
- 2016 <u>HILLARY RODHAM CLINTON</u> IS THE FIRST WOMAN TO BE NOMINATED FOR PRESIDENT BY A MAJOR POLITICAL PARTY.
- 2024 <u>Kamala Harris</u>, First female U.S. Vice-President, making her the highest ranking female official in US History and the first African American and the first Asian American vice president. The 49th Vice President became the Democratic party's nominee in the 2024 U.S. Presidential election, becoming the second woman nominated for president by a major U.S. Political party.

Kid-Friendly Non-Spicy Chili

Prep: 7 minutes Cook: 21 minutes

EQUIPMENT:

1 large pot

INGREDIENTS:

2 tablespoons olive oil

1 medium onion - chopped

1 red bell pepper -chopped

2 carrots peeled & finely chopped

2 stalks celery chopped

3 cloves garlic minced

3 cups vegetable broth

28 ounce can diced tomatoes

or 3 cups tomatoes, chopped

1 cup frozen corn

15-ounce canned pinto beans, drained & rinsed

15-ounce canned black beans, drained & rinsed

15-ounce canned kidney beans, drained & rinsed

1 Tablespoon tomato paste

1 ½ Tablespoon chili powder

1 ½ Tablespoon cumin

2 Teaspoon oregano

½ Teaspoon salt

1/2 Teaspoon cayenne pepper

1/2 Tablespoon red wine vinegar



TOPPINGS:

Cilantro Sour Cream Shredded Cheddar Cheese Corn Chips

INSTRUCTIONS:

- Heat oil on medium in a large stock pot.
 Add onion, pepper, carrots, celery and garlic.
 Stir and sauté for 3-5 minutes.
- Add broth, tomatoes, corn, beans, tomato paste, and spices.
 Stir together. Increase heat, bring mixture to a boil, and boil lightly (slightly more than a simmer) for 12-15 mins.
- 3. Bring heat to low and stir in red wine vinegar. After 1 minute, remove from heat.
- 4. Scoop into bowls and have fun with toppings!
