**Purpose:** To provide scholarships to relatives of eligible PESU members in good standing, are active in supporting the community in which they live and show an eagerness to achieve through knowledge by pursuing post-high school courses of study at either college or university.

Refer to criteria below for eligibility requirements, application process and a list of the supporting documents needed (i.e., reference forms, evidence of GPA, etc.) Incomplete applications will not be considered.

You will be notified by email in June regarding the status of your application.

Scholarship funds will only be awarded to the student upon receipt of a college and/or university acceptance letter.

#### Criteria:

- Applicant must be a PESU member in good standing or an immediate relative (spouse or child(ren)) of a current PESU member in good standing.
- Applicant must be a current matriculating student at a college/university in the year of the scholarship award.
- Applicant must demonstrate positive-impact involvement consisting of community service, determined through letters of recommendation.
- Minimum GPA of 2.75
- This is a ONE-TIME scholarship opportunity

#### **Application Process:**

Applicant must submit the following items:

- Completed application form.
- Three (3) letters of recommendations from choice of college professors, administrators, counselors, employers, or individual with significant knowledge of applicant's experience and involvement.
- An official and recent high school and/or college/university transcript with cumulative grade point average of 2.75
  on a 4.0 scale.
- Essay- In a minimum of 500 words, please answer the essay questions. No handwritten essays will be accepted.
